

BID NOTICE UNDER OPEN DOMESTIC BIDDING

- 1. The Government of Uganda through **Office of the President** has allocated funds to be used for **Supply and delivery of assorted office furniture under 3 Lots**
 - Lot 1: Locally made Furniture.
 - Lot 2: Executive Furniture.
 - Lot 3: Ordinary Furniture.
- 2. The Entity invites sealed bids from eligible bidders for the provision of the above Supplies.
- 3. Bidding will be conducted in accordance with the **Open Domestic Bidding Method** contained in the Public Procurement and Disposal of Public Assets Act, 2003, as amended and is open to all bidders.
- 4. Interested eligible bidders may obtain further information and inspect the bidding document at the address given below at 7 (a) from **9:00 am to 4:00 pm during official working hours.**
- 5. The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 7 (a) and upon payment of a non-refundable fee of UGX 100,000/= (Uganda Shillings One Hundred Thousand Only). The method of payment will be by Bank Advise Form obtained from the Office of the President Accounts Section or Uganda Revenue Authority website/offices. Payment can be made in any Bank and the payment details presented to the Procurement and Disposal Unit before obtaining a copy of the bidding document, cash will not be acceptable.
- 6. Bids must be delivered to the address below at 7 (a) at or before 10:00 am on 14th January, 2022. All bids must be accompanied by a Bid Security in Form of a Bank Guarantee of;
 - Lot 1: UGX 9,000,000/= (Uganda Shillings Nine Million Only)
 - Lot 2: UGX 7,000,000/= (Uganda Shillings Seven Million Only)
 - Lot 3: UGX 5,000,000/= (Uganda Shillings Five Million Only

Bid securities must be valid until **28**th **August**, **2022**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives, who choose to attend at the address below at 7 (a) **10:30 am on 14**th **January**, **2022**.
