The Government of Uganda (GOU) represented by **Office of the President (OP)** has allocated funds to be used for the acquisition of a consultant to provide Contract Management Consultancy Services to Monitor and Oversee, on behalf of GOU, the Development of the Government Office Campus at Bwebajja.
- 2. The Entity invites your sealed Proposals for the provision of the above services.
- 3. Bidding will be conducted in accordance with Open International Bidding contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003 as amended and the procedures described in Part 1: Proposal Procedures.
- 4. Preference Scheme shall apply when evaluating proposals from the firms. The target group for the Preference Scheme is the local (National/Resident) Consultancy Firms.
- 5. Firms may associate with other firms in the form of a Joint venture, Association, Consortium or a Sub- consultant to enhance their qualifications. The form of association where applicable the **Lead Firm** should be clearly indicated in the Proposal. Foreign firms **must** associate with Local Firms.
- 6. You may obtain further information and inspect the Proposal Documents at the address given below at 10 (a) from 8:30 am to 5:00 pm.
- 7. The Request for Proposal Document in English may be purchased by interested bidders on the submission of a written application to the address below at 9(a) and upon payment of a non-refundable fee of **UGX 100,000=** (Uganda Shillings One Hundred Thousand). The method of payment will be by Bank Advise Form obtained from the OP Accounts Section, or Uganda Revenue Authority website/offices. Payment can be made in any bank and the payment details presented to the Procurement and Disposal Unit before obtaining a copy of the Request for Proposal Document (RFP). Cash will not be acceptable.

- 8. Proposals must be delivered to the address below at 10(a) at or before 10:00 am. Late proposals shall be rejected. Proposals will be opened at 10(a) at 10:30 am on 30th September, 2022. All Proposals must be accompanied with a Proposal Securing Declaration valid until 8/05/2023
